## Minutes - Jenny

## Treasurer's Report - Mo

The report was distributed to all attendees and included both a yearly summary and March-April information. For the benefit of the attendees Mo explained the status of accounts and explained the use of funds. #### **Membership Report - Mo**

The Silent Auction generated \$2,145 and the 50/50 Raffle generated another \$300 due to the winner donating his proceeds to back to Reigning Grace. There was an additional \$30 onsite donation made. The Silent Auction proceeds will be used for the year ending charitable giving program by RVHA with input from the recent membership survey results.

Other activities mentioned were the Toys for Tots drive in December; donations to Board approved local charities for the 2018 year end; the very successful Christmas Lights Tour; and Snake Training offered to members and non-members, which resulted in 3 new members.

#### **FAA Contest**

Lori explained the leadership-building skills, the goals of the organization and the involvement members have with showing and raising animals. Students may participate through their senior year of high school.

In January, Lori proposed to the RVHA Board, an essay contest for student to obtain FAA jackets to be sponsored by RVHA. Of the nine essays received, 6 met the criteria and were reviewed by an independent panel and keep the participants names anonymous during process. The 6 candidates selected will receive jackets at an approximate cost of \$500. A motion was made to approve the expense and seconded, passed without comment. Photos will be taken of the recipients wearing their jackets and posted on the website. A newsletter article will follow along with selected examples of the essays. #### PiAware Antenna

Randy has been working with a group of volunteers using PiAware antenna equipment to monitor and report on low flying aircraft over our community. He also helps to coordinate efforts to set meetings with appropriate organizations to address concerns and help find solutions.

## 2. Dynamite Foothills

a. Fiesta Ranch - So of RVD, 136<sup>th</sup> - 142<sup>nd</sup>

The thumb of land s/e of RV Drive and 136<sup>th</sup> the City picked-up when the Preserve was developed. This Lyle Anderson project will be 260 homes
On 273 acres – Pending. Big gated entrances at 138<sup>th</sup> and 141<sup>st</sup>. Excellent locations for more

roundabouts, don't you think?...

b. Sonoran Peaks – 118<sup>th</sup> & Ranch Gate Rd

43 homes on 68 ac - Approved

c. Asteria Highlands – 128th & Ranch Gate Rd

31 homes on 40 ac - Pending

d. Sereno Canyon - 124th & Ranch Gate Rd

Toll Bros project of 257-367 homes on 258 acres

Phase 1 opens today with homes starting at \$1.4MM.

B-I-G project.

e. Storyrock-128th & Ranch Gate Rd

Shea in contract to build the first 51 of 443 homes on this 462 ac property. Really B-I-G project.

Takeaway – expect more roundabouts on the Drive and Happy Valley Road to be elevated to freeway status.
