#### Reports

#### Minutes - Jenny

# **Spring Dinner Dance**

Claudia indicated Big Sky Fox Trotters venue is no longer available, but did not expand on the reason or how she acquired the information. Claudia suggested a happy hour event at Harold's though it was thought members may not want to drive to a distant location for a gathering.

Due to the previously mentioned financial constraints, improved planning to budget for the band and meal costs is necessary since those costs can no longer be absorbed by RVHA. This situation makes catered events expensive for the members and may not be an attractive option for social events due to per person cost. Having a pot luck event was suggested as an alternative based on the success of the happy hour reception event in September at Arizona Cowboy College.

Mo or Carmela will check back with Box Bar Ranch to confirm pricing as costs could have changed since the last time this location was considered.

Mo will send an email soliciting input from members for potential locations and events for 2016.

Carmela will check with the Rural Metro fire station as the location and venue are suited to a dinner dance event. There is plenty of space for a band and dancing with a cement floor. It was suggested the dinner dance be less formal and include a potluck appetizer format with a small band for dancing.

#### **Rattlesnake Class**

Jenny is working with Brad from Rattlesnake Solutions to provide a no cost clinic on how to live peacefully with rattlesnakes and to dispel myths and misinformation. It is an educational program for residents of desert environments. Lori offered her bunk house, which has the required TV monitor for a presentation. Jenny will coordinate with Rattlesnake Solutions and Lori to determine date. Goal is to offer presentation before the snakes wake up from hibernation. Minimum of 20 attendees is required so all Board members need to show up if attendance is low from membership — or recruit attendees to take your place.

# **Development**

There is preliminary discussion of development for a convenience store, clinic and perhaps other services at the corner of Forest Road and Rio Verde Drive on property owned by Trilogy. More information is being researched.

The Outpost, a development submitted several times for approval has finally received approval from the City of Scottsdale for the northwest corner of Pima Road and Dynamite Boulevard. A gas station, convenience store and restaurant of some type is planned. Since buildings along Dynamite east of Pima are largely vacant, residents are concerned about the viability of this venture.
