Reports

Minutes - Jenny

The minutes from the March meeting were distributed via email prior to the meeting. A motion was made to accept the minutes, seconded, passed without comment.

Treasurer's Report – Judy

The March report was distributed to the Board members including the quarterly comparison. There was a question concerning the reimbursement for a survey expense (\$26). The expense covered one month of an enhanced survey tool on Survey Monkey to allow more than nine questions to appear in the membership survey and to include the RVHA logo. The service has since been cancelled so this was a one-time expense. A motion to accept the report was made and seconded and there were no additional questions or comments.

Membership Report - Mo

As of this date there are 564 members. Of those, 59 are new for 2015.

Facebook Report - Terry

There are currently 470 "likes" on the site, which is a significant increase from the last report. Terry attributed the increase in large part to the postings regarding the tragic shooting and killing of the horse, Gringo and the news updates that followed. There has been an increase in the sharing and posting of information. Terry reposts information from other sites as appropriate. Terry and Mo have approval authority for posts from members to the RVHA site.

Terry asked for opinions about sharing information with other community sites. After discussion it was decided that RVHA will not generally share information on the Rio Verde Bulletin Board due to the often negative nature of comments made – the messaging is not the same culture as RVHA has established. The other site, Rio Verde Swip Swap is for sale of items and free opportunities and it serves a different purpose than the dissemination of information and sharing of events and activities from RVHA. Terry will continue to monitor both sites and cross post information, such as lost and found animals as appropriate.

Email Discussion of Board Business

Occasionally in the interest of time or efficiency topics are discussed by the Board via email and may also be voted on as appropriate with the email serving as a report. In order to capture this information into the formal record of the minutes, Mo or other Board members will summarize email actions at the next regularly scheduled Board meeting.

Large Animal Rescue – a discussion took place via email in March to sponsor someone from our
area to participate in the next rescue training program. A decision was needed early in order to
secure space. The training fee was donated by RVHA and the program will be held at America
West. Rural Metro will be sending a sergeant to be trained in this program utilizing RVHA's
donation.
