Reports

Minutes – Jenny

The minutes from the January meeting were distributed via email prior to the meeting. A motion was made to accept the minutes, seconded, passed without comment.

Treasurer's Report – Judy

Mo explained the history of preparing a comparison of current and previous years in the financial report. Mo suggested moving to the sample format provided at this meeting to display just the current year because it is easier to read. The comparison will be done every quarter to assess status. The Board was in agreement to try the suggested format.
