Minutes – Jenny

The minutes from the April 2, 2014 meeting were previously distributed via email with one minor correction noted. Jenny noted that the Election Day event is listed as April 24 and April 26 is the correct date. A motion was made to approve the minutes and seconded without discussion. Marjorie has a copy for the website posting.

Treasurer's Report - Judy

The report was distributed by email. Judy advised waiting until close to the end of the year to make the second set of charitable donations for 2014 to ensure funds are available. When the announcement is made to the membership regarding the election of officers there will be a reference included that the year-end Treasurer's report will be available by email upon request. Old Business

Welcome Committee - Claudia

Claudia is working on the design and is not happy with the layout. She obtained a quote from the printer and it was recommended that for the slight cost difference the cards be designed to allow full color with bleed. A higher quantity can be printed and some will not have the "welcome" message so that the cards may be used by Board members for thank you notes or donation notices, etc. It was suggested that the printer be asked to provide design assistance, which will help maintain continuity with the newsletter design. Claudia will re-bid with three options including spelling out RVHA. Email address should be added to the back of the card with contact information. Suggested copy edit to "…over 600" and reference "members" instead of "residents."

Water/Aquifer Committee – Annie Hodgkins reporting

Annie distributed a draft copy of the overview of the committee and a suggested survey. The survey is to be used to obtain information from the community to establish a baseline of information to which future changes may be compared.

There was a discussion of well share situations so that the survey descriptions are more accurate, i.e., 900 wells does not equate to one household per well. The question was raised if a dried-up well is reported, how would it be known who/which well is being discussed? It was suggested that the survey ask: Is the well shared? Is the well on your (respondent's) property? And allow for exceptions to be noted in a comment box.

There was a brief discussion of well adjudication and the ADWR database shortfalls. The Committee targets June for distribution of the survey and will begin with RVHA membership list.

Area Plan Committee Update – Marjorie reporting

There have been two meetings of the full committee. There are nine members currently and each member has been assigned a topic to research. Nancy will edit to ensure continuity when the reports are compiled.

The committee is sharing articles and the plans from other similar communities to see what can be added to the current plan. The goal is to submit recommendations to the County in early 2015.

Terry mentioned Don would be interested in participation and Randy also volunteered. The next meeting is Saturday, June 7 at 10:00am at Carol Shuler's home. Mo will let Carol know that additional volunteers may be attending to determine their level of interest in participation.

New Business

Roadside Clean-up Committee

John and Cindy Shy have moved out of the area. Three members have volunteered to take over responsibility for the roadside clean-up events. Sabrina Nelson and Randy and Lisa Goettsche. The new committee will determine the schedule. Mo invited a committee member to the June Board of Directors meeting to present the plan for this committee.

McDowell Sonoran Preserve Proposed Step-overs

Photos were distributed of the proposed designs (prototypes in place) for entrances to the Preserve in an effort to keep out off-road vehicles. It was felt that the current designs are too dangerous if the horse becomes frightened and negotiation near road traffic could be hazardous. It was suggested that strongly worded signage be placed at every access point with a telephone number to report violations and a warning regarding the potential of arrest and fines. It was also suggested that a reward for information leading to an arrest be offered. The signs should serve as an intimidation factor to deter unlawful use of the Preserve. A separate RVHA position statement will be sent for approval of the Board members and then submitted to Scott Hamilton per his request for input.

Barb's Trail Update

Carmela reported that the naming of the trail was approved at the Scottsdale McDowell Sonoran Conservancy meeting last month and will go to Scottsdale City Council for approval in June.

Road Erosion

Randy questioned responsibility for maintenance of 152nd Street north of Lorill Equestrian Center where erosion has caused extensive damage to the road. Lori will ask the property owner adjacent to the damaged area if any improvement is planned.
