# Reports:

### Minutes – Jenny

Minutes for the combined Annual Meeting of Membership and Board of Directors meeting on April 29 were distributed previously by email for review. Due to the April 29 Board meeting there was no meeting scheduled in May. A motion was made to approve minutes, seconded, approved without discussion.

### **Treasurer's Report – Mo**

The report was prepared by Judy and submitted by Mo after review. A motion was made to accept the report, seconded and approved without discussion.

### Membership – Mo

Membership currently is 446 with 58 new members for 2018 and 37 lifetime members. A reminder was made that after July 1 the annual membership dues are reduced by 50%.

### Water Task Force Report – Carmela

Carmela reported on the last Task Force meeting that included a presentation given by the City of Scottsdale liaison. The presentation indicated at what levels the City would consider cutting off supplies to Rio Verde Foothills in the event of drought. The New River/Desert Hills area has completed the process to secure a supply of water for those communities. The arrangement includes a caveat on homes receiving hauled water prior to January 2018. After that time, the owners of newly constructed homes would have to secure their own water source.

A Maricopa County representative provided a presentation on DWID and what it can and cannot do. A water source needs to be determined first. Various sources have been contacted, but nothing has yet been determined. Meetings will resume in September.

Carmela clarified that Water Facts is a new Facebook page with a separate focus from the Water Task Force.

# Area Awareness – Terry

Mike, chair, and Terry attended a meeting at Scottsdale National Golf Club with the construction and design staff of the Club.
